To maintain the discipline and efficiency in the working of society. To make appointments of the employees and terminate their services if required.

**XIX. SOURCES OF INCOME, FUNDS  
AND UTILIZATION**

:- Membership fees, Donations, Govt.-grants. & to accept contribution / Donation from the Foreign contribution. The funds will be utilized on the objects of the society.

**XX. PERCENTAGE OF EXPENCES  
ON OBJECTS**

:- 50 % On Social Education & 50 % On Other Object.

**XXI. PROVISIONS REGARDING  
LOAN/DEPOSITS**

:- At the time of seeking financial borrowings from any trustee/bank or any person prior permission from the proper authority must be obtained.

**XXII. PROVISION REGARDING  
SALE/PURCHASE OF  
PROPERTY**

:- Society can purchase any kind of immovable and movable property. At the time of sale of immovable property the resolution passed by the Managing Committee by the majority and after that the society shall take necessary prior permission from the proper authority for the sale of immovable property.

#### **XIV. REQUISITION MEETING OF**

#### **MANAGING COMMITTEE**

:- A requisition meeting will be held with the requisition of 4 members of Managing Committee. Three days prior notice is required for calling such requisition meeting. Discussion in such meetings shall be limited to the agenda stated in the notice of such requisition meeting. Quorum of such meeting shall be 3/5 of the Managing Committee. Meeting shall be adjourned for want of quorum and such adjourned meeting shall take place after half an hour at the same place and date and no quorum is required for such adjourned meeting. But notice must reflect such information. The notice should be sent by hand delivery or by post

#### **XV. EMERGENCY MEETING OF MANAGING COMMITTEE**

:- For discussion on emergency subjects, emergency meeting shall be called with 12 hours notice. Such notice must reflect agenda, time, place and date of meeting. Quorum shall be 3/5 of Managing Committee members. For want of quorum, meeting shall be adjourned and after an hour at the same place and date emergency meeting shall take place. No quorum shall be necessary for such adjourned meeting shall take place, but notice must reflect such information.

:- The members shall be informed personally and their signatures shall be taken in notice book or by postal acknowledgement. The notice of emergency meeting shall be given writing.

#### **XVI. PROCEDURE OF NOTICE**

#### **XVII. FILLING OF VACANCIES OF**

:- Any vacancy arising due to death, resignation or by any other reason shall be filled in by the majority of Managing Committee for remaining period only.

## **2. Vice-President**

To call meetings of the Society, to make correspondence, entertain the complaints. To maintain proceedings of the Society. To prepare Annual Accounts and put forward for approval before General Council. To approve bills, to execute the approved proposals, to issue notices of the meeting, if required by the Society. To keep watch on the overall workings of the society. To represent the Society in other offices and Court & to execute election programme

## **4. Jt.-Secretary**

To hold the responsibilities of the Secretary in absence of the Secretary and to help him in all respects in working of the society.

## **5. Treasurer**

To keep appropriate accounts, to prepare final Accounts, to Collect donations, Funds, Membership-fees and put all the accounts in the managing Committee and General Council Meeting.

## **6. Members of Managing Committee**

To attend the general council and managing Committee Meetings, to vote in the meeting of Society.

## **XIII. MEETING OF MANAGING COMMITTEE AND QUORUM :-**

At least 3 meetings will be held within a year of Managing Committee. The notice of the meeting be served 7 days in advance, by hand delivery or by post. Notice must reflect the date, time, place and agenda of the meeting called for. Quorum required is 2/3 of the total members of Managing Committee. No quorum is required for adjourned meeting and such meeting will be held on the same day at the same place after an hour. But notice must reflect such information.

An extra ordinary meeting of General Council can be called as and when required, agenda will be discussed only for which the meeting was called for 15 days notice is necessary. Quorum will be 3/5 of the total members of General council, No quorum is required for the adjourned meeting. But notice must reflect such information..

## **XI. RULES REGARDING TENURE AND PROCEDURE OF ELECTION OF MANAGING COMMITTEE :**

The elections of the Managing Committee shall be held after every five years in the General Council Meeting. All members can participate, contest and vote in election. But member should not be in any type of arrears/fees/dues of the Society. Eligibility for the contesting the election is atleast 18 years in age. Elections shall be decided by all the members of the society by Majority. If the contest occured in the election that time general rules of election shall applied & the election will take with secret ballot paper.

## **XII. POWERS AND DUTIES OF OFFICE BEARERS :**

### **1. President.**

To conduct the proceedings of the meetings, to issue appropriate orders for the benefit of the Society, to control the proceedings of the Society and to give casting vote in the event of equal votes.

Handwritten signatures of the office bearers: President, Vice-President, Secretary, and Treasurer, along with their respective dates of appointment.

## **VI. RULES REGRADING DISMEMBERSHIP :**

The Managing Committee shall pass a resolution in its meeting for dismembering a member by 2/3 majority for the following reasons.

1. If he/she remains absent for 3 meeting consecutively without intimation.
2. If his/her behaviour proves to be harmful in the interest of the society.
3. If his/her behaviour appears against the rules of the Society.
4. If the ordinary member not pays the membership fees within 3 months after completion of the year,his/her membership will be ceased automatically.
5. If he found to be a unsound mind, bankrupt and imprisoned or involve in anti-social activity.

## **VII. POWERS & DUTIES OF GENERAL COUNCIL :**

General Council shall be the Supreme Body. All members can participate in the General Council meeting. It shall be held at least once in a year. To take final decision,to pass the budget and audit reports produced before the meeting, to prepare new programmes in the interest of the Society, if needed to form sub-committees, to amend the constitution and to elect Managing Committee.

## **VIII. NOTICE & QUORUM OF GENERAL COUNCIL :**

Notice for the meeting of General Council will be served 7days earlier with hand delivery or by post. Notice must reflect date, time, place and Agenda of the meeting. The quorum for the meeting will be 2/3 of the total members. Any adjourned meeting due to lack of quorum shall be held at the same place after half an hour on the same day. No quorum is required for the adjourned meeting. But notice must reflect such information.

<b>(II) JURISDICTION</b>	<b>:</b>	The Jurisdiction of Society shall be limited throughout the all India .
<b>(III) ACCOUNTING YEAR</b>	<b>:</b>	Accounting year will be from 1st April to 31 March every year.

#### **IV. MEMBERSHIP & ITS ENROLLMENT :-**

A person having the age of more than 18 years can be member of the society, who want to become a member, he/she has to make an application on prescribed form to the Managing Committee through Secretary. After acceptance of membership fee will be deposited by such person and there after he will be enrolled as a member. Managing Committee has a right to reject membership form without assinging any reason.

#### **V. CATEGORIES OF MEMBERSHIP :-**

##### **1. Founder Member :**

The members of the First Managing Committee who have signed the Memorandum of Association. They are the life member of the Society. Founder Member Should pay Rs.100/- as a Founder Membership fees.

##### **2. Life Member :**

One who contributes Rs.501/- as entry fee and Rs.51/- in Lumpsum shall be the life Member of the Society. His/Her tenure will be for the whole life.

##### **3. Ordinary Member :**

Who contributes Rs.21/- per year shall be the ordinary Member of the Society. Entry fee will be Rs.5/- only.
